

# Order of the Minister of Health of the Republic of Kazakhstan dated September 25, 2017 No. 720 ed. 11/15/2017

#### I ORDER:

## 1. Approve:

- 1) a list of positions of medical workers of centers for the prevention and control of acquired immunodeficiency syndrome (hereinafter referred to as AIDS), employees of research organizations, research and production associations and their structural subdivisions, including those in the production of bacterial and viral drugs, who are given an additional payment of in the amount of 60% of the official salary for the diagnosis, treatment of patients with AIDS and the human immunodeficiency virus (hereinafter referred to as HIV) infected, for carrying out all types of laboratory research of materials, for the production of bacterial and viral preparations, for conducting research work on the problems of HIV-AIDS in accordance with Appendix 1 to this order;
- 2) a list of organizations and positions of employees for which an additional payment for special working conditions is established in accordance with Appendix 2 to this order.
- 2. Recognize invalid the order of the Minister of Health of the Republic of Kazakhstan dated July 30, 2010 No. 576 "On approval of the Rules for additional payment for the qualification category and the List of organizations and positions of employees who are set additional payment for working conditions" (registered in the Register of State Registration of Normative Legal Acts under No. 6442, published in the newspaper "Kazakhstanskaya Pravda" dated September 14, 2010 No. 241 (26301).
- 3. The Department of Finance of the Ministry of Health of the Republic of Kazakhstan in the manner prescribed by law to ensure:
  - 1) state registration of this order with the Ministry of Justice of the Republic of Kazakhstan:
  - 2) within ten calendar days from the date of state registration of this order with the Ministry of Justice of the Republic of Kazakhstan

its copies in paper and electronic form in Kazakh and Russian languages to the Republican State Enterprise on the right of economic management "Republican Center for Legal Information" of the Ministry of Justice of the Republic of Kazakhstan for official publication and inclusion in the Standard Control Bank of regulatory legal acts of the Republic of Kazakhstan;

- 3) placement of this order on the Internet resource of the Ministry of Health of the Republic of Kazakhstan;
- 4) within ten working days after the state registration of this order with the Ministry of Justice of the Republic of Kazakhstan, submission to the Legal Service Department of the Ministry of Health of the Republic of Kazakhstan of information on the implementation of the measures provided for in subparagraphs 1), 2) and 3) of this paragraph.
- 4. To impose control over the execution of this order on the executive secretary of the Ministry of Health of the Republic of Kazakhstan Tokezhanov B.T.
- 5. This order shall enter into force ten calendar days after the day of its first official publication.
